- If you are not registered in the Swedish population register, a certificate proving that you are not prohibited from carrying on business or an equivalent document from another country within the EEA.
- Certificate proving that you do not have a custodian pursuant to Article 11, section 7 of the Parental Code – apply for the certificate from your municipality of residence.
