Information

1. Applicant

Fill in the personal information, including the address, of the applicant. The applicant can also be a legal entity. If the applicant is a legal entity you must write the business name that is stated in the certificate of registration, or a corresponding foreign document. You must also fill in the company registration number.

2. Representative

Fill in the personal details, including address, of the representative, if you have assigned a representative.

3. Company that issued the share certificates

Fill in the company registration number and business name of the company that issued the lost share certificates. A company cannot own its own shares.

4. Lost share certificates

Fill in the numbers that specify the shares that have been lost, and what class category they belongs to, if there are multiple classes.

5. Information regarding the share certificates

It is important that you answer the questions thoroughly in order for us to be able to process your case.

6. Signature

The applicant must sign the application. The representative can sign the application if he or she has a power of attorney. If the applicant is a legal entity the application must be signed by an authorized signatory.

Attachments

- Separate power of attorney and letter of authority to transfer, if you or your company uses one. The power of attorney must be signed by you or your company's authorised signatory. You must attach the original document.
- Copies of the lost share certificates or similar documents that contain the same information. Specify which share certificate it is.
- Copy of the share register. Alternatively a copy of the first page of the share register along with the pages that pertain to the lost share certificates.
- Copy of the police report, if the share certificates have been stolen or perished in a fire.
- If the applicant is a company that is not registered at the Swedish Companies Registration Office, you must also attach a proof of registration and other documents that show who is authorized to represent the company.
- Certified copy of the estate inventory or estate distribution deed along with a power of attorney from any beneficiary who has not signed the application.
