Information

Use this form when you want to apply to terminate lost securities, such as interim certificates, warrant certificates, convertible bonds or subscription warrants. More information is available on bolagsverket.se.

1. Applicant

Fill in the personal information, including the address, of the applicant. The applicant can also be a legal entity. If the applicant is a legal entity you must write the business name that is stated in the certificate of registration, or a corresponding foreign document. You must also fill in the company registration number.

2. Representative

Fill in the personal details, including address, of the representative, if you have assigned a representative.

3. Company that issued the securities

Fill in the company registration number and business name of the company that issued the lost securities.

4. Lost securities

Tick the box stating what type of security that has been lost. Also fill in the number or other information that is on the security, for example the date when the security was issued or the name that the security was made out to.

5. Information regarding the securities

It is important that you answer the questions thoroughly in order for us to be able to process your case.

6. Signature

The applicant must sign the application. The representative can sign the application if he or she has a power of attorney. If the applicant is a legal entity the application must be signed by an authorized signatory.

Bilagor

- Copies of the lost share certificates or similar documents that contain the same information.
- Document that corroborates that the security has been lost – if the security has been stolen or perished in a fire, for example a report from the Police or the Fire Department.
- A separate statement from the pledgee that accounts for how they have stored, lost and searched for the security.
- If the applicant is a company that is not registered at the Swedish Companies Registration Office, you must also attach a proof of registration and other documents that show who is authorized to represent the company.
- Separate power of attorney and letter of authority to transfer, if you or your company uses one. The power of attorney must be signed by you or your company's authorised signatory. You must attach the original document.
- Certified copy of the estate inventory or estate distribution deed along with a power of attorney from any beneficiary who has not signed the application.
